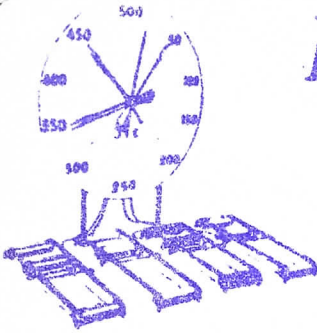

PLACE & TIME: Every Sunday afternoon, 1:00 p.m. to 4:00 p.m. at the following locations and dates:

- EVENT #1: January 6, 1974 Salem Mall, Dayton, Ohio. Take Rt. 49 Exit from I-70, or Salem Ave. Exit from I-75.
- EVENT #2: January 13, 1974 Richmond Square Mall, Richmond, Indiana. The Mall is located on National Road East in Richmond.
- EVENT #3: January 20, 1974 Southtown Mall, Ft. Wayne, Indiana. The Mall is located on Rt. 27 in Ft. Wayne.
- EVENT #4: January 27, 1974 Dayton Mall, Dayton, Ohio. Take the Rt. 725 East Exit from I-75. The Mall is on the corner of Rt. 725 and Rt. 741.
- EVENT #5: February 3, 1974 Tri-County Shopping Center, Cincinnati, Ohio. Take 275 West from I-75 or I-71 and exit at Rt. 747.
- EVENT #6: February 10, 1974 French Field House, Ohio State University, Columbus, Ohio. The Field House is located on Lane Ave. on Ohio State University Campus.

EVENTS: Roller races at 1500 meters Time Trial and 1500 meters match races. Match races will be run off as single elimination. Final positions will be decided by total of points compiled in both the Time Trial and the match races. All events are rolling start. There will be separate A, B, and C class races, with classification decided by performance in the Time Trial.

PRIZES: 8 places each in A, B, and C classes, with minimum of \$200 in prizes for each event in the series, PLUS additional prizes for the top 4 riders in A, B, and C classes in the OVERALL STANDINGS, which will be decided by the riders' best performances in 4 of the 6 events held. Thus it will be to riders' advantage to ride as many of the events as possible.

EQUIPMENT: Road or Track bikes. Gear limit is 96.4 inches maximum (50 x 14). If riding a road bike, derailleurs must be set so that it will not shift into a gear larger than the above limit. Wheel size will be maximum of 27", crank minimum 165 mm. Bring own rollers for warm-up. Races will be run off on JIC 4-man Competition Rollers.

ENTRY FEE: \$2.25 per event for all classes A, B, and C. Riders must show ABL license. 1973 cards will be accepted. Pay entry fee at registration on race day.

IMPORTANT: The last event in the series, held at French Field House in Columbus, will be billed as the "MIDWEST ROLLER RACE CHAMPIONSHIP", with extensive promotion to attract riders and spectators. Be sure to attend.
